Synopsis

In August 2012, peoples and governments of ASEAN member states will commemorate the 45th anniversary of the establishment of the Southeast Asian regional grouping. As a response to the growing importance of the ongoing integration processes in Southeast Asia, the Association for International Affairs and five ASEAN embassies in the Czech Republic with the kind support of the Ministry of Foreign Affairs of the Czech Republic have jointly organized an international conference dedicated to the evaluation of ASEAN's past achievements and discussion on its future prospects.

"Southeast Asia", which stands for more than ASEAN today – in the same way as "Europe" stands for much more than today's European Union – was faced with many tensions and the risk of serious conflict back in 1967 when the five nations joined hands to create this new regional grouping. Peace and stability didn't come naturally to the region and were not automatically the expected situation 30, 40 or 50 years ago. Once it is achieved, stability is easily taken for granted while anguish and destruction caused by wars that prevailed before stability was achieved are easily forgotten. ASEAN has for 45 years been seeking to achieve peace and prosperity for its peoples through regional cooperation and integration. Two keywords guiding this process have been soft approach and multilateralism. After 45 years of progressing quietly and cautiously, Southeast Asian nations have achieved three major successes, which are nowadays often taken for granted, but were certainly not the expected outcome 45 year ago: peace and stability in the region, economic and institutional integration, and the ASEAN plus project or ASEAN's 'regional architecture'.

This conference primarily aims to assess past developments and future prospects of the ASEAN integration process with an emphasis on economic, political-security, and socio-cultural aspects. In light of many shared interests between ASEAN and the European Union (EU), the conference also aspires to stimulate public discussion and promote awareness in the Czech Republic, both among the policy-makers and public at large, on various economic and socio-political issues related to ASEAN. To this end, the speakers in three panels will discuss lessons ASEAN can learn from the Union's own experience of integration and benefits of regional co-operation while also pondering possible areas where the EU could learn lessons from the ASEAN experience.

Panel I: ASEAN Political-Security Community in 2015: Is It Possible?

ASEAN is moving rapidly to forge a stronger political and security identity, with members engaged in an array of new initiatives designed to create such an ambitious community in 2015. What are the implications of the reforms that are now underway in Myanmar for ASEAN's political momentum? What impact could have the APSC blueprint adopted in 2009 for the realization of the ASEAN Political-Security Community? Why are the conflicting territorial claims in the South China Sea and unresolved border conflicts of a great concern among the architects of the ASEAN integration? Why have the rise of China and the continuing 'hub-and-spoke' strategy of the United States in the Asia-Pacific and the interactions between these two major powers increased tensions within South East Asian region?

Panel II: ASEAN Economic Integration: What Can ASEAN Learn from the EU Experience?

ASEAN's economic integration process has been advancing. However, when compared with the EU's economic integration, ASEAN's achievements in this area are still very modest. What implications has ASEAN's emphasis on 'widening' rather than 'deepening' had for its economic integration? Has the unique ASEAN model, in spite of its shallow and less institutionalized form, brought some noticeable outcomes in terms of trade and investment relations as well as its external competitiveness? To what degree can ASEAN be compared with the EU-style economic integration, particularly in light of the current debt and competitiveness crisis in the EU?

Panel III: Realizing the Vision of an ASEAN Socio-Cultural Community: Challenges and Opportunities

'Diversity' is a concept that accurately captures Southeast Asia. ASEAN's quest for community building is an ambitious project in that it seeks to produce a common social and cultural community which will showcase the much-vaunted adage 'unity in diversity'. To what degree has ASEAN succeeded in managing its immense political, socio-cultural and economic diversity on the way to create a 'we'-feeling among its peoples, feeling of belonging to one ASEAN Community? While the ASCC may be achieved by 2015 on paper, is it feasible to have also the peoples of ASEAN realize one common ASEAN identity?
