# Participants' Bios

## Olga Chládková



Olga works as a producer and journalist at ARD TV Studio Brussels. She is covering EU and Benelux politics for the Tagesschau and the ARD Europamagazin. ## Živá paměť

Projekt Živá paměť města Liberec-Reichenberg představuje město prostřednictvím vyprávění zdejších pamětníků. Vztah k místu vzniká a vyvíjí se nejen vnímáním prostředí, které nás obklopuje, ale zejména díky vlastním pocitům, zážitkům a poznávání příběhů, které se na každém místě neviditelně ukládají.

Způsob, jakým chceme naše město nově představit, spočívá ve sbírání vzpomínek obyvatel města Liberce na ulice, náměstí a budovy. Nehodláme zveřejňovat obecné informace, ale chceme předat osobní zkušenost, a to v podobě, ve které jsme měli tu čest ji sami vyslechnout. Naučný charakter tohoto projektu není založený na vědeckém výkladu historie, ale na emocích, které autentické výpovědi vyvolávají.

Němá, mnohdy všední místa budou moci promluvit hlasy svých pamětníků o dětství, o práci, o nadějných plánech, ale i o marnosti, o životě, jenž se tu odehrál i v jaký doufáme. Všední kulisy města se znovu stanou scénou dramatických událostí i běhu obyčejných dnů, které utvářely a stále utvářejí současnou libereckou veřejnost. Mlčenlivé části města svědčí o skutečných lidských osudech, které se v nich odehrály.

Das Projekt "Lebendige Erinnerung der Stadt Liberec-Reichenberg" stellt die Stadt durch Erzählungen der Reichenberger Zeitzeugen vor. Die Beziehung zu einem Ort entsteht und entwickelt sich nicht nur durch Beobachtung der Umgebung, in der wir uns befinden, sondern auch durch Erlebnisse, die uns mit dem Ort verbinden und die an jedem Ort gespeichert werden.

Die Art, durch die wir unsere Stadt neu vorstellen möchten, steckt in der Sammlung von Erinnerungen der Reichenberger Einwohner an Straßen, Plätze und Gebäude. Wir wollen nicht allgemeine Informationen sondern persönliche Erfahrungen präsentieren, und zwar in der Form, wie wir die Ehre hatten sie selbst zu hören.

Sprachlose, oft alltägliche Orte beginnen durch die Stimme der Zeitzeugen zu sprechen. Über die Kindheit, über die Arbeit, über Träume, aber auch über Misserfolge, über viele Menschenleben, die hier gelebt worden sind, und über das Leben, an das wir glauben. Gewöhnliche Gesichter der Stadt werden so wieder zur Kulisse von dramatischen Ereignissen und ungewöhnlichen Tagen. Wortlose Teile der Stadt werden so zu Zeugen von menschlichem Leben, die sich dort abgespielt haben.

## Kino Varšava

The construction of the "Kinokavárna" in the former Varšava cinema in Liberec, Czech Republic, is a result of a local civic project, whose aim is to reconstruct the building of one the last standing stone cinemas in Liberec, cinema Varšava. Two German architects from Liberec, Effenberger and Noppes, designed this beautiful art deco building in 1922 for an enlightened businessman, Franz Sieber. At this time, it was the first stone cinema in Liberec. The building itself connected two different levels: Mariánská and Frýdlantská street. It had three floors including a foyer, a balcony and an auditorium, and a loft with a car workshop. This functional model was inspired by US business models. The building was heavily affected by the radical political changes that Liberec, formerly known as Reichenberg, had undergone throughout the 20th century. The last large-scale reconstruction work took place in the 1960s. Decorative motifs on the facade were dismantled and many windows that were previously used as natural ventilation for the space were bricked, thus, damaging much of the building. In 2008, due to competition from newly built multiplexes and the increasing burden on the city to provide financial means of support, the city resolved to shut down the cinema.

In the year 2012, the city wanted to sell the building due to a budgeting crisis of the municipality. To oppose this plan, a new civic association, "Let's save cinema Varšava," was formed. Unfortunately, it was not possible to avoid the sale of the upper part of the building, where a pizzeria is currently situated. Once the partial sale of the building had been realized, the city council consequently leased the auditorium, the foyer and the balcony to the civic association. At this time, there was no heating in the building, the technical infrastructure was destroyed and all the wooden structures in the auditorium were infected by fungal timber decay. Despite these dire conditions, the association started to operate the cinema. The city council decided to fund the basic reconstruction work with the profits gained from the sale of the pizzeria. It allocated 65, 000 € to the project of reconstructing the foyer and started to further cooperate with the association. Despite this low budget, the construction work on the foyer was finished with an enormous help from the sponsors, the contractors who offered labour and material discounts, and from dozens of volunteers.

Three members of the civic association, all of who are architects, designed the plans for the reconstruction. The architectural conception intends to connect the old with the new and to add a fresh element to the great building of the past. It was necessary to clear the detrimental components of the previous structure and to add some contemporary ones. The bricked ventilation windows were broken through and the decorative stuccos were remade. Meanwhile, the original brass lights, located below the auditorium, were repaired and returned to their original place between the curls of the suspended ceiling.

The purpose of the reconstruction was to discover the design qualities of the past, not to glorify them or to deny them. It urged to enhance the old structure and to avoid any spiritless building reconstruction, which we witness nowadays all too often. A large part of the design and reconstruction work could not have been accomplished without the great contribution of dozens of volunteers who want to create a more pleasant space in the city they live in.

## Cableway Ještěd

The Ještěd cableway is among the oldest classical aerial cableways. It was financed by Czechoslovak State Railways and built by the renowned Chrudim company of František Wiesner. Construction was launched on 15 June 1932 and the completed cableway began

operating on 27 June 1933. Between 1971 and 1975 the cableway underwent an extensive reconstruction as a result of which it became a world-class cableway. The reconstruction was performed by the company Transporta Chrudim and the reconstructed cableway began operating on 31 December 1975.

## Ještěd Tower

As far back as 1838 the summit hosted a crude stone that serves as a landmark to this day. The first hut on the summit was erected as early as 1844. In the 1860s, the mountain ridge was Station No. 4 of the first order of the Royal Saxon triangulation. For this reason a measuring station was built on the summit. In 1906, the Mountain Club, a mountain hotel, was built. The Jeschke Horní Hanychov cable car to the summit was opened in 1933. On 23 August 1940, at midnight, a Heinkel He 111 from the Second (Lion) Squadron (German: Löwengeschwader) from Lüneburg crashed into the mountain near the summit and tore a long swathe in the woods. This accident killed the four crew. The old mountain hotel burned down in 1963. Between 1966 and 1973, a futuristic hotel, with a 100-metrehigh television tower, was built that was designed by the architect, Karel Hubacek. For the construction of the TV tower, Hubacek was awarded the Auguste Perret Prize. The modern building acts as a lookout tower, transmission tower, hotel and restaurant.

# PEGIDA – PATRIOTIC EUROPEANS AGAINST THE ISLAMISATION OF THE WEST

Pegida (German: Patriotische Europäer gegen die Islamisierung des Abendlandes) is a nationalist, anti-islam, far-right political movement. It started as a phenomenon in East Germany and resulted in a German wide, political protest-movement.

It started in Dresden in October 2014, at the time more refugees reached Germany, especially people with Muslim background. Pegida was founded by Lutz Bachmann. Every Monday the supporters of Pegida meet in the streets of Dresden to demonstrate against the German and European Asylum policy and the Islamisation. In only 4 months, the movement grew significantly from 350 supporters in October 2014 to 25 000 in January 2015, which also describes its peak. At the same time counter demonstrations were organised. These counter-demonstrations reached a similar number of supporters, resulting in huge pro-contra demonstrations with a broad police operation. In 2016 Pegida still organises demonstrations every Monday, but the support shrank, also because of internal fights between the leaders of the movement. In the last months between 1000-3000 people attended the demonstrations. The extreme rise of supporters in 2015 can be seen in other cities as well. Throughout Germany several offshoots have been formed in the last two years. The biggest ones are Legida in Leipzig, Dügida in Düsseldorf or Hogesa. But not only in Germany, also in other European countries similar movements started cooperating with each other.

The statements given on the demonstrations and in speeches by supporters are often xenophobic and racist, especially against people with a Muslim background. In the position paper, Pegida formulates 19 bulleted statements, including: Pegida approves the right of asylum for war refugees and politically persecuted people. Pegida suggests modelling German immigration policy after those of Switzerland and the Netherlands. Pegida demands an increase in funding for the police. Pegida demands enforcement of all asylum laws including expulsion. Nevertheless the political position of Pegida stays diffuse and the reasons for the supporters to attend the protest are varying. So are the supporters themselves. The demonstrations became a platform for people to show their fears, anger and aggression, most of the time addressed against the state, foreigners and the media. In

result of that, the spectrum of people is quite broad. Beside supporters, who can be identified as members of the Neo-Nazi scene, there are also people from a moderate class of society.

With Pegida emerging two years ago, racism in daily life is growing and becoming more common and societal accepted. In addition to that, attacks against refugee camps are rising as well. Even though it is hard to find scientific prove for a relation between these two situations, it is clear that Pegida created a growing xenophobic atmosphere.
